## PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On the above date, I was driving Northbound around 6800 blk of Royal Palm Beach Blvd, in unincorporated Palm Beach County (Acreeage). I observed a Silver Chevy Silverado pickup driving three vehicles in front me. The Chevy was driving 16 mph in a 45 mph zone. The two other vehicles behind the Chevy had to pass the pickup due to its slow speed and impeding traffic flow. I then noticed as I got behind the Chevy that the vehicle drifted to the right almost striking a mailbox. The Chevy then drifted quickly to the left maintaining 16 mph and crossed over the double yellow line into the southbound lanes of travel. I was operating a marked PBO issued Police Harley Davidson Motorcycle behind the Chevy. The Chevy entered the turn that transitions the roadway from Royal Palm Bch Blvd into Orange Blvd. The driver could not maneuver the Chevy through the left turn without crossing the yellow dividing lines and almost struck the right curb. I activated my emergency lights and siren to stop the Chevy. The driver turned the Chevy down 120 Ave North and continued to drive as I activated my siren to 68 Street North. I had to ride beside the vehicle on the drivers side to yell at the driver to pull over to the right. The driver window was down and I could see that the driver had a blank stare to his face and appeared to be dazed. The driver stopped in the middle of the roadway as I proceeded to yell at him to pull off into the grass. I made contact with the driver who stopped on the west side of 120 Ave. The driver had trouble placing his vehicle in park and turn the truck off. I asked the driver for his license which he pulled out his wallet and fumbled through it while he looked for his DL. He found the DL after a minute or so at which time I asked him if he had been drinking. Driver Hareesh Vishnudat, identified by his DL, answered, "I'm not going to lie, I had a few beers". I could smell an overwhelming odor of an alcoholic beverage coming from his breath as he answered. His eyes were extremely bloodshot and eyelids wide open. He just stared with a daze, as puzzled that I was talking to him. I asked Hareesh if he knew where he was since his DL stated he lived in City of Royal Palm Bch, not the Acreeage community. He stated that he was in the City of Lake Worth. Deputy Morin responded as a backup deputy to assist me with traffic since I was operating a PBO motorcycle. He had no contact with the driver. Due to his actions and statements, I called for a DUI Unit to respond to the scene. Deputy Tejeda responded and took over the investigation.

## OBSERVATION OF DRIVER:

Upon making contact with the defendant who was passed out asleep in the driver seat of his vehicle. I immediately smelled an obvious odor of an unknown alcoholic beverage coming from within the vehicle. Once I woke him up, I observed the defendant's eyes to be glassy, watery, and blood shot. I also observed the defendant to have a slow and slurred speech. The defendant had a pale and flushed face. The defendant was also lethargic. The defendant was asked to step out of his vehicle and speak with me in front of my patrol car, as he stepped out of his car he staggered to the side and had an unstable balance. I also observed the defendant to have a sway as he stood normally without walking.

## DRIVER'S STATEMENTS:

The defendant stated he has no physical defects or injuries. He stated he has no medical conditions. He stated he is not taking any medications. He stated he has not hit his head recently. He stated he was on his way home from a funeral. He stated today's date was July 20th, he then stated June 20th. He stated he was unsure what the current time was, it was actually 1134PM. He stated he was in Lake Worth. He stated he has not smoked any marijuana or used any illegal drugs today. He stated he drank a lot. When he was asked what a lot was, he stated he was unsure but drank a lot. He stated he is a driver and last worked last night. He then stated I know he is drunk and I should just take him to jail. He also stated he was lost and was unsure where he was.

## ODORS:

An obvious odor of an unknown alcoholic beverage coming from his breath which intensified as he spoke with me.

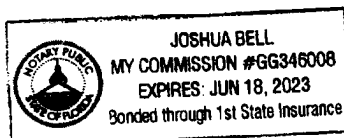

The defendant was placed into the instructional stance for the Horizontal Gaze Nystagmus. He verbally identified the blue stimulus that I was holding up. He was told to follow the stimulus with his eyes only and not move his head. I checked his eyes for equal pupil size, equal tracking, and resting nystagmus. I observed a lack of smooth pursuit in both eyes. I observed distinct and sustained nystagmus at maximum deviation in both eyes. He was reminded several times not to move his head. I did not observe any vertical nystagmus in either eye. He swayed from side to side. The defendant stopped doing the task early.

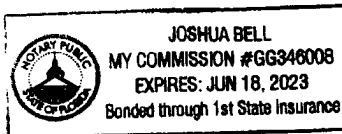

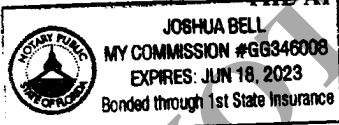
