statement post miranda. Kathleen stated her uncle, Harold J Pashley (08/23/1971) was highly intoxicated and drinking alcohol since last night. Kathleen stated her mother, Jennifer L Pashley (12/23/1974) had taken her Red Chevrolet pick-up truck bearing FL plate: NQZE79 and driven the truck to the police department.

Jennifer parked the pick up truck in the front lot so that Harold would not drive under the influence. The Chevrolet truck was registered only to Jennifer and not to Harold. Kathleen stated that Harold woke her up because he was yelling in the living room at Jennifer. The arguing awoke Kathleen and she started to yell at Harold to stop yelling so that she could return to sleep. Harold then replied "NO!" to Kathleen. Kathleen stated that she picked up a orange bowl from on top of the kitchen table and threw the bowl in Harold's direction.

Kathleen stated the bowl did not strike/ touch Harold. Harold in return pushes Kathleen in the torso, with open palms. Kathleen stated she lost her balance and stumbled backwards but, did not have injuries. Kathleen stated she then left the apartment to make contact with her mother over the phone. Kathleen subsequently called the police on a 911 recorded line for assistance.

I then met with Jennifer. Jennifer provided me with a sworn statement post miranda. Jennifer stated that Harold had been drinking and was intoxicated since last evening. Jennifer stated she feared that Harold would leave the apartment and drive her Chevrolet pick up truck (Described above), intoxicated. Jennifer took the truck to the police department parking lot and parked the truck out of Harold's immediate control. Jennifer stated she woke up today to Harold drinking more alcohol. Jennifer would not relinquish her car keys to Harold. Jennifer left the apartment.

Harold becomes upset and starts to scream and yell at Jennifer over the phone. Jennifer was not present during the altercation between Kathleen and Harold.

I then make contact with Harold at the apartment. Harold appeared to be intoxicated, with slurred speech, glassy and blood shot eyes, with the odor of alcohol coming from his breath. Harold provided me with a sworn statement post miranda. Harold stated he was upset that his girlfriend Jennifer because she took his keys to his truck and would not return with the truck. Harold stated that he called Jennifer and got into an argument over the phone. Harold stated he was getting loud and that Kathleen came out of her room to confront him.

Harold stated that Kathleen threw a orange bowl from the table at him which hit him in the stomach. Harold stated he was not injured. Harold stated that Kathleen then threw a box containing medication at him. Harold stated that Kathleen was yelling at him so he pushed her to get her away from him. Harold started to drink and take large gulps of Whiskey when officer's were on scene. Harold stated he was "Drunk last night" and "Did not remember what happened". I observed a 2 inch laceration to Harold's right pinky finger which was bleeding. Harold stated he injured his right pinky finger but, could not recall how he injured his hand. Harold confessed to pushing Kathleen. Harold admitted to me that he is an alcoholic.

Based on the fact that Harold is intoxicated to the point where he is beyond his reasonable faculties I cannot take his statement as being credible. Harold admitted to not knowing what happened last night and not knowing how he came to be injured. Harold continued to drink alcohol even on scene with officer's. Harold was agitated and yelled at officer's several times throughout his statement. Based on the above statements I find Harold to be the primary aggressor in this battery case.
