The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On December 5, 2019, on Hillsborough Av. W. and Countryway Bl. the defendant was operating his gray 2019 Subaru STI bearing Florida license plate#: Z91HAW (VIN: JF1VA2S60K9810314) West on Hillsborough Av. W. The defendant failed to negotiate a turn and struck a large brick sign causing approximately \$8500.00 in damages. Witness Scott Romanov provided sworn testimony that he observed the vehicle collision and observed the defendant get out of the driver's seat. Deputy J. Kolodziejski ABN#:254944 responded and observed the defendant to have bloodshot and glassy eyes, to be unsteady on his feet, have severely slurred speech, and to have the strong odor of an alcoholic beverage emanating from his breath. I met with the defendant and observed him to have bloodshot and glassy eyes, slurred speech, to be unsteady of his feet, to sway while standing, to have eyelid tremors, and I detected the strong odor of an alcoholic beverage emanating from his breath. The defendant performed standardized field sobriety exercises poorly indicating impairment. Once at Central Breath Testing, after being advised of the Implied Consent Warning, the defendant refused to provide lawful breath samples. I confirmed the defendant's identity via DAVID.
