The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above offense date, time and address, the victim and defendant were involved in a verbal altercation. The verbal altercation later escalated into a physical altercation when the defendant knowingly and intentionally tackled the victim against his will. The victim and defendant struggled on the floor but were later separated by the witness. The victim, defendant and witness then relocated to the kitchen of the residence, at which point the defendant knowingly and intentionally struck the victim on his nose with a closed right fist against the victims will. The victim suffered a bloody nose and the small laceration on the left side of his forehead from the entire physical altercation. The victim and defendant are step father and step daughter and have been residing together at the offense address as a family. The victim identified the defendant as the person who committed the offense. Post Miranda, the defendant admitted to striking the victim with a closed right fist.
