 On the above listed date, time, and location I observed a white Ford F-250 bearing FL tag #NKUB44 (VIN:1FT7W2B68KEG83677) traveling eastbound on Brandon Bl. I paced this vehicle at 60 MPH in a posted 50 MPH zone. I observed this vehicle fail to maintain a single lane while traveling eastbound. I conducted a traffic stop at the above listed location. I made contact with the defendant on the driver side. I observed signs of impairment to include bloodshot watery eyes, slurred speech, and the distinct odor of an alcoholic beverage emitting from his breath. Post Miranda, the defendant admitted to consuming three beers. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises the defendant showed signs of impairment. The defendant was subsequently arrested for DUI. The defendant was read Implied Consent, and refused to provide a breath sample. The defendant was identified via Florida driver license.
