The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 23 day of NOVEMBER, 2019, at approximately 11:04 PM, at 5500 GULF BLVD, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE VICTIM, HER BOYFRIEND, AGAINST THE WILL OF VICTIM, TO-WIT: CLOSED FIST STRIKE, CAUSING ABRASION TO LEFT EYE BROW, AS WELL AS HITTING SEVERAL TIME IN THE BACK WITH HANDS AND PURSE.

THE DEFENDANT AND VICTIM HAVE BEEN DATING SINCE FEBRUARY 2019, AND RESIDED TOGETHER AS A FAMILY FROM AUGUST 1, 2019-NOVEMBER 1, 2019. ON THIS DATE THE DEFENDANT AND VICTIM WERE DRINKING AT THE TRADEWINDS BIKE FEST AND BEGAN ARGUING IN THE PARKING LOT AFTER. THE DEFENDANT FORCEFULLY PULLED THE VICTIM'S HELMET OFF, AND STRUCK HIM IN THE FACE, CAUSING AN ABRASION TO HIS LEFT EYEBROW. THE VICTIM GRABBED THE HELMET BACK AND THE DEFENDANT HELD ON AND BEGAN STRIKING THE VICTIM IN THE BACK NUMEROUS TIMES WITH HANDS AND HER PURSE.

POST-MIRANDA THE DEFENDANT DENIED PUNCHING THE VICTIM AND SAID THE ABRASION WAS EITHER FROM HER DOG THIS MORNING, OR A FIGHT AT THE BIKE FEST. THE DEFENDANT SAID SHE DIDNT THINK SHE SWUNG HER PURSE AND HIT HIM BUT SHE WASN'T SURE.

THE DEFENDANT WAS INTOXICATED AT THE TIME OF CONTACT WITH HER.

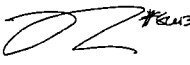

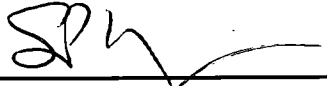
ADVISORY AND SOLVENCY HEARING

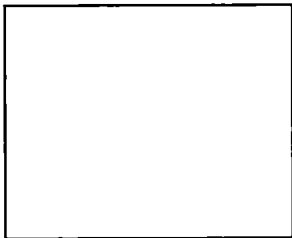
