

The following was captured on my body worn camera:

On 07/08/2021, at approximately 2148 hours, I was sitting in my fully marked Jupiter Police K9 Vehicle (#1715) in the median on Military Trail just north of University Blvd. I was utilizing my Stalker 2 MDR radar in the stationary mode. I observed a vehicle (bearing FL tag Z46FAP) driving northbound in the inside lane exceeding the posted 45 mph speed zone. At this time, I made a uturn to conduct a traffic stop on the vehicle. I caught up to the vehicle at Military Trail and Dakota Dr. I then activated my overhead lights to conduct a traffic stop. The following occurred:

After activating my overhead lights, the vehicle approached Indian Creek Pkwy at a red light. The light turned green shortly after the vehicles came to a complete stop. Once the light turned green, the vehicle continued to travel northbound in the inside lane at approximately 44 mph. After a short period, I activated my siren to notify the driver that I was attempting to stop the vehicle. During the time, the vehicle did not pull over and stayed in it lane at the same constant speed. The vehicle then turned left into the parking lot of Culvers (1108 Military Trail). After entering the parking lot, the vehicle continued to drive through the lot to enter the back entrance to Barcelona apartments. The vehicle came to a final stop behind 117 Riena Way. Once the vehicle stopped, the driver (later identified as W/F Heather E Towe 12/19/1977) immediately exited the vehicle, I was able to have the driver sit back into the vehicle.

After speaking to Towe, I asked her for her reason on why did she not stop. Towe advised she did not know she was being pulled over and was just going home. I then advised Towe she was under arrest for fail to obey or comply with law enforcement official. Towe was issued citation for speeding and citation for her charge. She was transported to Jupiter Police Department and later transported to PBSO jail.

I found probable cause to charge Heather E Towe with fail to obey or comply with LE or FD official because she fail or refuse to comply with any lawful order or direction of any law enforcement officer.
