The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a white 2019 BMW 320i, 4 door, Florida tag T61FM. The defendant was stopped for unlawful speed. The defendant drove at 51 MPH in a properly posted 35 MPH speed limit (visually estimated and patrol car 5153 paced). The defendant drove onto painted lane markers, and once a traffic stop was initiated she was slow to respond to stop. The defendant had a dazed look about her face, appeared impaired, and fumbled with documents displaying poor dexterity. The defendant was easily distracted and forgetful as related to documents that had been requested of her at the start of the traffic stop. The defendant had a distinct odor of an alcoholic beverage on her breath, her eyes were bloodshot and watery, and her face was flushed. The defendant's speech was low and occasionally slurred. The defendant stated that she drank two (2) White Claw alcoholic drinks tonight. The defendant swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and she was arrested for DUI. The defendant provided breath samples of .115% BrAC and .116% BrAC. The defendant was positively identified by her Florida DL.
