The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 3/12/2021 at approximately 9:32 pm, Trooper Angelicchi conducted a traffic stop on a maroon Scion Xb on I-4 (SR 400) at mile marker 5 eastbound. The traffic stop was for speeding 85 miles per hour in a posted 65 mile per hour zone. While following the suspect vehicle I observed the vehicle started to straddle the line and appeared to try to exit at mile marker 3. That was when the suspect vehicle swerved to the right in order to continue on I-4.

Once the vehicle stopped on the left shoulder, I approached from the driver's side. I observed a white female in the driver's seat and alone in the suspect vehicle. I immediately detected the odor of alcohol emitting from her person. I also noticed the suspect had bloodshot watery eyes and was fumbling to provided her FL DL.

The suspect provided an FL DL that positively identified the suspect as Heather Nicole Key (DOB: 4/21/1976). The suspect admitted to drinking earlier, however she insisted she was fine. When speaking to the suspect, her speech was a little thick. I requested the suspect to shutdown her vehicle and removed the key. I requested back up and prepared my patrol vehicle for a DUI investigation.

The suspect exited the vehicle and started to shuffle her feet while walking to the front of my patrol vehicle. The suspect denied any physical or medical issues that would hinder her performance in the Field Sobriety Exercises.

HGN (Horizontal Gaze Nystagmus) Exercise

During this exercise, the suspect failed to follow instructions by turning her head or looking past the stimulus. I had to remind the suspect several times how to perform the exercise correctly. I did not observe the suspect exhibit resting nystagmus or unequal pupil size. I did observe the suspect display equal tracking in both eyes. I observed the following clues of impairment in both eyes; Lack of Smooth Pursuit, Distinct Sustained Nystagmus at Maximum Deviation, and an immediate Angle of Onset. The suspect also exhibited VGN (Vertical Gaze Nystagmus) and LOC (Lack of Convergence) in both eyes.

Walk and Turn Exercise

On this exercise, the suspect failed to follow instructions by moving during the instructional phase by removing her right foot to regain her balance. The suspect also failed to follow instructions by attempting to start the exercise prior to finishing the instructional phase. On the walk forward, the suspect missed heel to toe on steps 2, 7, and 8. The suspect made an improper turn failing to pivot on her front foot while taking small steps with the other. I observed the suspect fail to follow instructions by stopping the exercise after attempting the turn. On the walk forward, the suspect missed heel to toe on steps 1, 2, 3, 4, 5, and 8. The suspect also stepped off the line on step 9. I observed the suspect utilize her arms for balance.

During this exercise, the suspect failed to follow instructions by not looking at her foot throughout her performance. The suspect also failed to follow instructions by having her raised foot less than six inches from the ground. The suspect displayed a noticeable sway and utilize her arms for balance. The suspect counted to 19 in 30 seconds' time.

After the Field Sobriety Exercises were complete, I handcuffed the above subject and informed her she was under arrest for Driving Under the Influence. She was escorted to the front seat of my patrol vehicle and secured while an inventory of her vehicle was conducted. I requested the suspect provide a breath sample when at the Hillsborough County Jail. The suspect refused and was immediately read her implied consent. The suspect (Mrs. Key) still refused to provide a breath sample. The following offense occurred in Hillsborough County, FL.
