The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the above-listed date and time, the witness observed a gray Ford Focus, bearing FL tag NXAB10 (VIN:3FADP31353R110522), being operated by the defendant. The witness observed the aforementioned vehicle in a traffic accident (HCSO 21-392312 DHSMV#89438091), against a median causing damage only to the vehicle. Upon deputy's arrival, they detected signs of impairment. The affiant responded to the scene and detected signs of impairment, which were bloodshot watery eyes and the distinct odor of an alcoholic beverage emitting from the defendant's breath. Post-Miranda, the defendant admitted to consuming one glass of wine. The affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide a lawful breath sample, which was .119/.119. The defendant was given DUI Citations, AA2S4XE, which reflects the charge. The defendant was identified via her FL DL.
