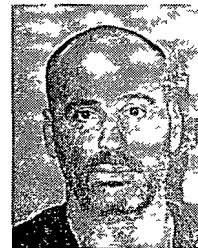

Probable Cause Affidavit

Before me this date personally appeared PEREZ, ERIC R (PD1095) who being first duly sworn deposes and says that on 28 day of April, (year) 2017 at 9299 W SAMPLE RD/UNIVERSITY DR, CORAL SPRINGS, FL 33065 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

SUBSTANCE. THE DEFENDANT DID THEN AND THERE UNLAWFULLY DRIVE, OR WAS IN PHYSICAL CONTROL OF A MOTOR VEHICLE TO WIT: A WHITE 2008 MERCEDES 4 DOOR, BEARING FLORIDA TAG EQXS01, WHILE HE WAS UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE OR CHEMICAL SUBSTANCE TO THE EXTENT THAT HIS NORMAL FACULTIES WERE IMPAIRED.

ON 4/28/2017, I RESPONDED TO THE ABOVE LISTED AREA TO ASSIST OFFICER VARA-VALDERRAMA WHO WAS CONDUCTING AN ACCIDENT INVESTIGATION (CASE 17-4085). UPON ARRIVING ON SCENE, I MADE CONTACT WITH THE ABOVE LISTED DEFENDANT WHO WAS SITTING IN THE FRONT DRIVERS SEAT OF A WHITE MERCEDES, AND LOOKING THROUGH PAPERWORK. AS I MADE CONTACT WITH THE DRIVER, I IMMEDIATELY SMELLED A STRONG ODOR OF AN ALCOHOLIC BEVERAGE EMANATING FROM THE INTERIOR OF THE VEHICLE. THE INDIVIDUAL, WHO WAS IDENTIFIED BY OFFICER KABAN BY HIS FLORIDA DRIVERS LICENSE, HAD WATERY BLOOD SHOT EYES. HE THEN EXITED HIS VEHICLE AFTER HE WAS UNABLE TO LOCATE HIS INSURANCE CARD. UPON EXITING THE VEHICLE, SIMIAND LOST HIS BALANCE AND BEGAN TO LEAN ON HIS VEHICLE. I WAS STANDING DIRECTLY IN FRONT OF SIMIAND AND SMELLED THE ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS PERSON. I ASKED SIMIAND IF HE HAD ANY MEDICAL CONDITIONS AND/OR IF HE TAKES ANY MEDICATIONS TO WHICH HE REPLIED "NO" TO BOTH. IN ADDITION, I ASKED SIMIAND IF HE WAS CURRENTLY UNDER A DOCTORS CARE, HE STATED NO.

BASED ON MY CONTACT WITH THE DEFENDANT, I BELIEVED THE DEFENDANT MIGHT HAVE BEEN UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE OR CONTROLLED SUBSTANCE TO THE EXTENT THAT HIS FACULTIES WERE IMPAIRED.

Before me this date personally appeared PEREZ, ERIC R (PD1095) who being first duly sworn deposes and says that on 28 day of April, (year) 2017 at 9299 W SAMPLE RD/UNIVERSITY DR, CORAL SPRINGS, FL 33065 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

IT SHOULD BE NOTED, THE DEFENDANT STATED THAT HE WAS FROM FRANCE AND HAS LIVED IN THE UNITED STATES FOR TWO YEARS. DESPITE ENGLISH BEING HIS SECOND LANGUAGE, THE DEFENDANT WAS ABLE TO SPEAK AND COMPREHEND THE ENGLISH LANGUAGE.

I ADVISED THE DEFENDANT HIS MIRANDA WARNINGS FROM A DEPARTMENT ISSUED TEXT WHICH HE UNDERSTOOD AND WAIVED.

POST MIRANDA, I ASKED THE DEFENDANT IF HE RECENTLY CONSUMED ANY ALCOHOLIC BEVERAGES, HE STATED YES, INDICATING THAT HE CONSUMED TWO YUNGLING BEERS WITH HIS FRIENDS EARLIER IN THE EVENING. I THEN ASKED THE DEFENDANT IF HE WOULD SUBMIT TO VOLUNTARY ROADSIDE SOBRIETY EXERCISES, WHICH HE CONSENTED TO.

OFC. KABAN BEGAN BY CONDUCTING A HORIZONTAL GAZE NYSTAGMUS (HGN) EXAMINATION OF THE DEFENDANT. I WAS ADVISED BY OFC KABAN THAT THE DEFENDANT DISPLAYED 6 OUT OF 6 CLUES, DISPLAYED VERTICAL GAZE NYSTAGMUS, AND DISPLAYED LACK OF CONVERGENCE WHICH IS CONSISTENT WITH ALCOHOL IMPAIRMENT.

I THEN ADMINISTERED THE WALK AND TURN EXERCISE BY READING THE INSTRUCTIONS TO THE DEFENDANT FROM A PRINTED TEXT, WHICH HE UNDERSTOOD. IT SHOULD BE NOTED THE DEFENDANT WAS UNABLE TO COMPLETE THIS EXERCISE. DURING INSTRUCTION, THE DEFENDANT WASN'T ABLE TO KEEP HIS BALANCE WHILE LISTENING TO THE INSTRUCTION. DEFENDANT BEGAN ATTEMPTING THE EXERCISE SEVERAL TIMES DURING THE INSTRUCTION, USING HIS ARMS FOR BALANCE (RAISING THEM TO SHOULDER HEIGHT). HE WAS ADVISED SEVERAL TIMES NOT TO START THE EXERCISE UNTIL HE WAS INSTRUCTED TO, WHICH HE FAILED TO COMPLY.

Before me this date personally appeared PEREZ, ERIC R (PD1095) who being first duly sworn deposes and says that on 28 day of April, (year) 2017 at 9299 W SAMPLE RD/UNIVERSITY DR, CORAL SPRINGS, FL 33065 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

I THEN ATTEMPTED TO ADMINISTER THE ONE LEG STAND EXERCISE WITH THE DEFENDANT. IT SHOULD BE NOTED THE DEFENDANT WASN'T ABLE TO COMPLETE THIS EXERCISE. DURING INSTRUCTION OF THIS EXERCISE, THE DEFENDANT WAS ADVISED PRIOR TO INSTRUCTION TO NOT START THE EXERCISE UNTIL HE WAS TOLD TO DO SO. DURING THE EXPLANATION AND DEMONSTRATION OF THE EXERCISE, HE IMMEDIATELY BEGAN ATTEMPTING THE EXERCISE. HE WAS ADVISED NOT TO START THE EXERCISE UNTIL THE EXPLANATION WAS COMPLETED, HOWEVER HE FAILED TO LISTEN TO MY INSTRUCTION. DURING HIS ATTEMPT OF THE EXERCISE, HE LOST HIS BALANCE AND BEGAN HOPPING ON ONE LEG. HE USED HIS ARMS FOR BALANCE, RAISING THEM TO SHOULDER HEIGHT FOR ASSISTANCE DURING EVERY ATTEMPT AT THE EXERCISE.

I THEN ATTEMPTED TO ASK THE DEFENDANT WHAT WAS THE HIGHEST NUMBER HE WAS ABLE TO COUNT TO. THE DEFENDANT STATED THE FOLLOWING: 1,2,3,5,6,11,7,11,8,11,12,10,11,13.

BASE ON THE CIRCUMSTANCES OF THE COLLISION AND MY OBSERVATIONS OF THE DEFENDANT, HE WAS PLACED UNDER ARREST AND TRANSPORTED TO CSPD FOR PROCESSING.

UPON ARRIVING TO THE BOOKING ROOM, I STARTED MY TWENTY MINUTE OBSERVATION OF THE DEFENDANT AT 0708 HRS. DURING THIS OBSERVATION TIME, THE DEFENDANT DID NOT REGURITATE OR INTRODUCE ANY SUBSTANCES INTO HIS MOUTH.
