The defendant was stopped for driving erratically when she was driving at inconsistent speeds, swerving, weaving, and straddling the lane divider. The defendant was driving her 2012 Volks CV, bearing FL tag LSK106. Upon making contact with the defendant, she displayed multiple signs of impairment, including: bloodshot/glassy eyes, slurred speech, a strong odor of an alcoholic beverage on her breath, fumbling with her documents, difficulty dividing her attention, unsteady on her feet, and an admission to consuming alcoholic beverages. The defendant refused to perform the SFSEs and was arrested for DUI. The defendant later refused to submit to the breath test, despite acknowledging the implied consent warning. The defendant had a prior refusal to submit to testing on 09-14-2016.

The defendant identified herself via her FL DL.
