The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 07/07/2021 at approximately 1040 hours at a residence located at 2401 Trapnell Rd. E. the defendant intentionally and unlawfully struck the defendant, who is 77 years old, against his will with a six inch long piece of a plastic hanger. The broken piece of hanger was recovered from the trunk of the defendant's vehicle during a consensual search of the vehicle, and perfectly matched the remaining part of the hanger which was located inside the victim's residence. The victim identified the defendant as the person who committed the offense. The victim is the father of the defendant and the two have lived together as family in the past. The defendant's identity was confirmed via DAVID photo.
