IN REFERENCE TO A DOMESTIC BATTERY

UPON ARRIVAL I OBSERVED HOLLIE ELWELL, HEREIN AFTER REFERRED TO AS THE ARRESTEE, AND _____ HEREIN AFTER REFERRED TO AS THE VICTIM, BOTH EXITING THE ABOVE MENTIONED LOCATION I MADE CONTACT WITH THE VICTIM WHO ADVISED THAT _____ GOT INTO AN ARGUMENT WITH THE ARRESTEE, WHO _____ ADVISED THAT THE ARRESTEE WAS ANGRY BECAUSE THE VICTIM CHANGED THE PASSWORD ON _____ PHONE AND WOULD NOT LET HER KNOW THE NEW CODE THIS ACTION INFURIATED THE ARRESTEE AND SHE BEGAN TO PUNCH THE DOOR TO THE MASTER BEDROOM THE VICTIM THEN ADVISED _____ ATTEMPTED TO GRAB HER FROM BEHIND IN AN EFFORT TO CALM HER DOWN, WHICH YIELDED NEGATIVE RESULTS THE ARRESTEE THEN LEFT THE ROOM AND GRABBED A KITCHEN KNIFE, WHICH SHE BROKE
