The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was stopped for weaving back and forth in her lane, crossing the fog line with the passenger side tire, and speeding. The defendant was driving her 2017 Hyundai 4dr, bearing FL tag #Z789ST. Upon making contact with the defendant, she displayed multiple indicators of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on her breath, slurred speech, and a club admissions wrist band on her right wrist. The defendant exhibited multiple clues of impairment during the SFSEs and was arrested for DUI. The defendant later refused to submit to the breath test, despite acknowledging the implied consent warning.

A search of the defendant's purse revealed an Aleve pill bottle containing two and a quarter pills of Alprazolam 2mg (1 white bar stamped "GG249" and 1 1/4 blue bars stamped "B707"). Also in the defendant's purse was the FL driver's license (#G616-015-99-942-0) of another person. The owner of the FL DL was not in the vehicle with the defendant.

The defendant identified herself via her FL driver's license.
