The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 05/15/2021 at approximately 0453 hours, near the interstate mile marker of 24000 I-75 South, Ruskin, Florida 33570. The defendant was observed by Deputy M. Ortiz (ABN: 258031) operating a Black 2020 AUDI Q5 bearing Florida tag EVMG25 with an assigned VIN of WA1ANAFY4L2016021 traveling well above the listed speed limit and effecting the general flow of traffic. While driving, Deputy Ortiz had to take evasive action to avoid being struck by the defendant. Deputy Ortiz completed a lawful traffic stop and observed multiple indicators of impairment from the defendant/driver. Upon the affiant's contact with the defendant, I observed him to have watery/glassy eyes, slurred speech, he was unsteady on his feet, and I smelled the odor of alcoholic beverage emitting from his breath. The defendant elected to participate in field sobriety exercises, and while doing so, he demonstrated further indicators of impairment. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration, he was placed under arrest for DUI. Search incident to arrest, revealed the defendant to be in possession of a white powdery substance in his shirt's left front pocket. White powdery substance was also located in the driver's side door of the vehicle, inside the lower exposed compartment. The white powdery substance was contained in a separate small clear baggies. The white powdery substance tested positive for Cocaine content via the QuickCheck Narcotics Test Kit. The defendant provided two lawful breath samples of .166 and .166, roadside. The defendant identified himself verbally. I further identified the defendant via DAVID photograph.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
