At approximately 2206 hours on Saturday, April 15th 2017, I responded to the incident location of the 1700-block of Southwest 4th Avenue, Fort Lauderdale, Broward County, Florida, in reference to a traffic stop with a suspected impaired driver. On my arrival, I observed the suspect vehicle (Red 2002 Ford F-150 pick-up truck, Florida Tag: UVF6E, VIN: 1FTRX17282NB58091) facing north in the south-bound lanes of travel. made contact with Officer Carter (#1817) of the Fort Lauderdale Police Department, who advised me the following;

He observed the above listed suspect vehicle traveling west-bound on Southwest 20th Street approaching Southwest 4th Avenue. The intersection, in that particular direction of travel, is regulated by a Traffic Control Device (Stop Sign). The suspect vehicle proceeded through the stop sign without stopping, making a right hand turn to go north-bound. With sufficient speed from not stopping, the suspect vehicle did not manage to safely negotiate the right hand turn. The vehicle went wide, struck the center median (a raised concrete curb), and proceeded north in the south-bound lanes. Officer Carter proceeded to catch up to the vehicle to initiate a traffic stop, where he observed the vehicle pass several opportunities to correct its lane of travel, and it did not. On making contact with the driver, he observed several signs of impairment (Slurred speech, bloodshot eyes, difficulty answering questions, inability to identify registration as the document requested when it was in his hand), and requested D.U.I. Task Force respond. At no point was he able to produce a driver's license. was identified as Howard Barrow via D.A.V.I.D., and he was the sole occupant of the motor vehicle at the time of the incident.
