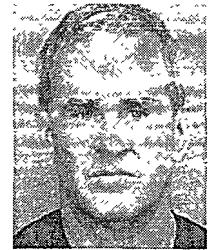

Probable Cause Affidavit

Before me this date personally appeared WILLIAMS, SEAN (16345) who being first duly sworn deposes and says that on 15 day of April, (year) 2017 at 1700 SW 4TH AV, FORT LAUDERDALE, FL 33315 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

At approximately 2206 hours on Saturday, April 15th 2017, I responded to the incident location of the 1700-block of Southwest 4th Avenue, Fort Lauderdale, Broward County, Florida, in reference to a traffic stop with a suspected impaired driver. On my arrival, I observed the suspect vehicle (Red 2002 Ford F-150 pick-up truck, Florida Tag: UVF6E, VIN: 1FTRX17282NB58091) facing north in the south-bound lanes of travel. I made contact with Officer Carter (#1817) of the Fort Lauderdale Police Department, who advised me the following;

He observed the above listed suspect vehicle traveling west-bound on Southwest 20th Street approaching Southwest 4th Avenue. The intersection, in that particular direction of travel, is regulated by a Traffic Control Device (Stop Sign). The suspect vehicle proceeded through the stop sign without stopping, making a right hand turn to go north-bound. With sufficient speed from not stopping, the suspect vehicle did not manage to safely negotiate the right hand turn. The vehicle went wide, struck the center median (a raised concrete curb), and proceeded north in the south-bound lanes. Officer Carter proceeded to catch up to the vehicle to initiate a traffic stop, where he observed the vehicle pass several opportunities to correct its lane of travel, and it did not. On making contact with the driver, he observed several signs of impairment (Slurred speech, bloodshot eyes, difficulty answering questions, inability to identify registration as the document requested when it was in his hand), and requested D.U.I. Task Force respond. At no point was he able to produce a driver's license. The driver was identified as Howard Barrow via D.A.V.I.D., and he was the sole occupant of the motor vehicle at the time of the incident.

Probable Cause Affidavit

Before me this date personally appeared WILLIAMS, SEAN (16345) who being first duly sworn deposes and says that on 15 day of April, (year) 2017 at 1700 SW 4TH AV, FORT LAUDERDALE, FL 33315 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

I observed the suspect vehicle sitting in the inside lane in the south-bound lanes, facing north. The vehicle's positioning placed it to the left of the center median, and in lanes facing oncoming traffic. In the area from where Officer Carter first observed the vehicle enter the oncoming lanes of traffic to where the stop was, I observed two separate breaks in the median for turning vehicles to cross, which would have allowed the suspect vehicle to safely cross back into the correct lanes of travel. The first break was at Southwest 19th Street and the second break was at Southwest 18th Court. This was consistent with Officer Carter's statements.

On personal contact with the driver, who was seated against the center median, I observed the following signs of impairment; Avoided eye contact, admitted to drinking, unusual statements, the odor of alcohol coming from his breath when he spoke, his face was flushed, eyes glassy and bloodshot, slurred speech that was difficult to understand, and he was delayed in responding to direct simple questions such as address and phone numbers. He also made several statements to include that he had no idea how his truck had become located at the location of the stop. He advised he was heading home, where he was traveling away from the address he provided me as his current residence.

Based on my observations, I requested that he submit to some roadside exercises. He shook his head, and clarified that he would not perform them. I explained that the exercises were an opportunity for him to dispell my concern that he was impaired beyond his ability to operate a motor vehicle safely, and further stated that his refusal to submit to the exercises could be utilized against him. He stated he understood.

Probable Cause Affidavit

Before me this date personally appeared WILLIAMS, SEAN (16345) who being first duly sworn deposes and says that on 15 day of April, (year) 2017 at 1700 SW 4TH AV, FORT LAUDERDALE, FL 33315 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Based on the defendant's refusal to perform exercises and other observed factors, I determined I had probable cause to arrest the defendant. I placed the defendant under arrest for DUI, handcuffing (two handcuffs, double-locked) the defendant. I then requested the defendant submit to a lawful breath test, which Mr. Barrow agreed to submit to. The defendant was then searched and placed in my patrol vehicle. At this time, my BWC was deactivated after switching my in-car camera to observe the back seat. The defendant was then transported to the Broward Sheriff's Office BAT (Breath Alcohol Testing) unit located at 200 Northwest 27th Avenue, Fort Lauderdale, Broward County, Florida. With the assistance of BAT Technician Medina (#12280), the defendant was processed to provide a breath test. However, he began to complain that he was being 'tortured' because his [REDACTED] was hurting and he was handcuffed (again, with two handcuffs). He said he wasn't going to provide a breath test. I activated my Body Worn Camera (BWC) once more, and requested him to provide a breath test. When he said no, I read the Florida Implied Consent from prepared text, advising him of the consequences of refusal. After he acknowledged, he once more refused at 2307 hours.

A D.A.V.I.D. check of his history revealed a previous D.U.I. conviction from Broward County, Florida (Citation: 0866-XAC, Offense 11/21/2003, Conviction 01/26/2004).
