The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/25/2020, at approximately 2112 hours, the defendant was operating a 2006 grey Nissan Altima bearing FL tag Z558NL (VIN:1N4AL11D86N400960) on Kirby St W. The defendant left the roadway and struck a fence on the side of the road. The defendant then fled the scene without providing information. The witness/property owner is an off-duty HCSO Sergeant, and he observed the crash and provided responding deputies with the vehicle and defendant description. Deputy Kolodziejski observed a vehicle matching the description in the general area and confirmed the vehicle as the same vehicle involved in the crash. Deputy Kolodziejski observed the vehicle with front end damage and driving without headlights activated. Deputy Kolodziejski conducted a traffic stop at the intersection of Kirby St W / Glen Av N and came in contact with the defendant who was the driver and sole occupant. Deputy Kolodziejski and the off-duty Sergeant positively identified the defendant as the same individual involved in the crash. While speaking with the defendant, Deputy Kolodziejski detected signs of impairment. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to do. During the exercises, the defendant showed signs of impairment and was subsequently arrested. Post Implied Consent, the defendant refused to provide a lawful breath sample. The defendant was identified via FL DL. The defendant has a suspended license dated 11/12/2019 and has 1 prior DWLS conviction.							
The total damage that resulted in the traffic crash was valued at approximately 5,000.
