The Defendant and Victim are married. They have a two year old child in common and live together as a family. They have resided at 15350 Amberly Dr. Apt 4222 since September of 2019. On 07-29-2020 at approximately 1326 hours, I responded to the aforementioned address regarding an anonymous call about what sounded like a fight coming from the apartment. Upon my arrival, I made contact with the Victim who gave the following verbal statement. The Victim stated he and his wife became involved in a argument over the use of a lap top computer. The Victim said the Defendant attempted to take the lap top away from him. He said they pulled back and forth on the lap top. He said the Defendant then scratched his the left side of his neck and his chest with her fingernails. Scratch marks were freshly visible on the Victim's neck (left side) and on his chest. The scratch on his chest was still wet with blood.

The Defendant and Victim live together as if a family and have a child in common. The Defendant did batter the Victim by scratching his neck and chest. The Defendant spontaneously uttered that she scratched the Victim. The Defendant was arrested for Domestic Violence Battery. She was identified with a Saudi Arabian Passport. She is currently in the United States on a Student Visa.
