 On the listed date and time and at the above location, officers were dispatched to a disturbance at the intersection of Meridian Av S and Cumberland Av E in reference to the defendant yelling. Upon arrival, contact was made with the witness, who advised that he kicked the defendant out of the Park and Rec bar located at 290 Meridian Av S due to the defendant's behavior. The defendant was obviously intoxicated, agitated, and disturbing the peace of the bar patrons and nearby apartment resident who called in. The defendant was given multiple chances to call himself a ride; however, he continued to provide verbal resistance stating that he did not have to listen to us and that he wasn't going anywhere. Upon attempting to secure the defendant in handcuffs, he tensed his body, pulled away, and laid on his hands in order to prevent officers to accomplish handcuffing. While walking the defendant to the patrol car, he repeatedly made his body limp, requiring officers and the witness to physically carry him to the patrol car.

The defendant was positively identified via his Louisiana ID.
