On 06/27/2020 at approximately 0250 hours, I observed a silver Nissan bearing FL tag 9791UN traveling southbound in the 3000 block of S Ocean Blvd at a high rate of speed. The vehicle was also seen going off of the roadway onto the grass shoulder. I then conducted a traffic stop on the vehicle. I then spoke with the driver identified via FL DL as Tania Clermont B/F DOB 10/05/2000 and passenger identified FL DL as Hunter Marie Elizabeth Rose Armstrong W/F DOB 01/23/2001.


Clermont's driver's licenses was ran via radio, which Palm Beach Communications advised that Clermont had a learner's license. As I was speaking with Armstrong she was slurring her words and appeared to be under the influence. Due to this I could not have Armstrong drive the vehicle. Armstrong was listed as the registered owner of the vehicle. I asked Armstrong if she had anything illegal in the vehicle, which she stated "no". I then asked Armstrong if she would consent to a search of the vehicle, which she did give consent.

A search was conducted and I retrieved a blue pill with the stamp B707 inside a pink flower backpack. I immediately was able to identify the pill based off my training and experience as Alprazolam. The backpack was located where Armstrong was sitting and was the same bag Armstrong retrieved her identification. Armstrong was then read her Miranda Warnings from a pre-printed card provided to me by the Palm Beach Police Department.

Post Miranda, Armstrong stated the pink bag was hers and she had Xanax in her bag that she purchased earlier for \$5.

Based on the above facts there is probable cause to arrest Hunter Marie Elizabeth Rose Armstrong W/F DOB 01/23/2001 for Possession of Schedule IV Drug pursuant to F.S.S. 893.13(6)(a).
