The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On November 23th, 2019, at approximately 2358 hours, Deputy Jacobs #254973, was dispatched to a Reckless Driving call for service. The complainant advised HCSO Dispatch "a black SUV Volkswagen bearing Florida tag: Y58JEZ was driving recklessly and was all over the road going into oncoming traffic." Deputy Jacobs observed a black SUV Volkswagen bearing Florida tag: Y58JEZ matching the same description of the vehicle parked at the 4602 Sandy Creek Ln Tampa FL. Deputy Jacobs made contact with the defendant and detected signs of impairment. Deputy Jacobs observed the defendant in the driver seat with the keys in the ignition and the vehicle running. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to perform. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The affiant requested the defendant to provide a lawful breath sample to determine his breath alcohol content, which the defendant refused. The affiant read Implied Consent to the defendant in room #1 of Central Breath Testing, he understood and replied "I'm not blowing." The defendant received a DUI citation #A9IA8NE which reflects the DUI charge. The defendant was identified via his Florida Driver's License.
