The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12-31-2020, at approximately 0056 hours, in the parking lot in front of 18107 Peregrine Perch Pl: Lutz, FL 33558, the victim and defendant were engaged in a verbal argument over a text message. The defendant intentionally attempted to strike the victim, against his will while standing approximately two feet away, with her right hand approximately two times. This caused the victim to move his body and head away quickly to avoid being struck. The victim and the defendant have four children in common and resided together in the past for approximately 12 years as a family. The victim positively identified the defendant as the person who intentionally tried to strike him against his will. I positively identified the defendant via a DAVID photograph.
