The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 06/20/20, at approximately 0035 hours, Deputy R. Carr (ABN 260033) responded to the Wawa parking lot, which is located at 13026 US Hwy 301 S, in reference to a hit and run vehicle traffic crash. The complainant of the call stated the driver of a maroon Nissan Versa fled the scene into the adjacent parking lot and she did not appear to be okay. Deputy Carr circulated the area and made contact with the Nissan Versa, bearing Florida tag NQKP33, with an assigned VIN of 3N1CE2CP1EL351516, in the parking lot located at 9411 US Hwy 301 South. Deputy Carr observed the defendant to be passed out in the driver's seat of the vehicle with the engine running. Deputy Carr made contact with the defendant to check on her well being. Upon contact with the defendant, she had bloodshot glassy eyes, slurred speech, unsteady balance and the distinct odor of an alcoholic beverage emitted from her breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. The defendant then provided two lawful samples of her breath, resulting in a BAC of .184/.176. The defendant was identified via her Florida driver's license.
