at approximately 10:16 PM, at 12750 49TH STREET NORTH, in Pinellas County did:

THEN AND THERE UNLAWFULLY DRIVE AND/OR BE IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE WITHIN PINELLAS COUNTY, FLORIDA WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE, A CONTROLLED SUBSTANCE AND/OR ANY CHEMICAL SUBSTANCE TO THE EXTENT THAT HER NORMAL FACULTIES WERE IMPAIRED.

REASON FOR STOP: A BOLO WAS ISSUED FOR A BLUE PONTIAC VIBE, BEARING FLORIDA TAG CCYF13, ADVISING THE VEHICLE WAS BEING OPERATED BY A FEMALE WHO WAS SWERVING AND FAILING TO MAINTAIN HER LANE. THE BOLO WAS ISSUED AFTER MITCHEL BROWER NOTIFIED LAW ENFORCEMENT OF THE VEHICLE AND HE ADVISED THE VEHICLE WAS TRAVELING SOUTH ON THE BAYSIDE BRIDGE.

SGT. J. JONES LOCATED THE VEHICLE WHICH HE OBSERVED SWERVING. SGT. J. JONES OBSERVED THE VEHICLE NEARLY SWERVE INTO ANOTHER VEHICLE ON THE ROADWAY, PROMPTING HIM TO INITIATE A TRAFFIC STOP.

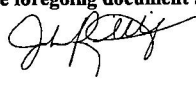

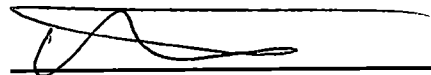
ADVISORY AND SOLVENCY HEARING

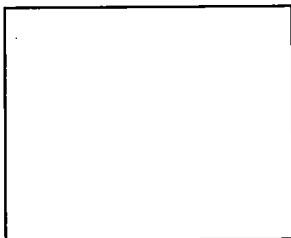
