The defendant went to the victim's residence and began to pound on the front door and ring the door bell frantically. The defendant was demanding to be let inside. The defendant then walked around the residence and pounded on all the windows with his fists. The victim and his family were awakened and frightened by the defendant's actions. The defendant struck a rear window so hard that he smashed it in, causing approximately \$ 100.00 in damage. The peace and quite of the victim's / family were greatly disturbed by the defendant's constant yelling and pounding. The defendant appeared to be very intoxicated to the victim. The victim also has "RING" video available of the defendant's actions.

On contact with the defendant by the affiant, the defendant displayed numerous and pronounced clues of intoxication. The defendant had slurred nonsensical speech, red watery eye, and was very unsteady on his feet. The defendant had no reasonable explanation for his actions.
