Officer Zachary Barker (ID 459), Officer Chad Witherspoon (ID 520), and Officer Christian Medina (ID 527) responded to the call and located a white male who was passed out drunk at the bar. Their body worn cameras were used on this call.</p> <p>Officer Z. Barker (ID 459) advised me of the following: Officers responded to the call and located the white male, later identified as Jack A. Collins (W/M DOB:04/27/03), who was passed out drunk at the bar. The male was purchasing alcoholic beverages from the establishment with a New Jersey (NJ) driver license (#C74408280008994). Officer Z. Barker (ID 459) asked the Collins for his drivers license and was presented with a Florida license (#C-452-421-03-147-0) that was vertical rather than horizontal. A Florida vertical license is commonly linked to a person who is under the age of 21. The other ID from NJ, used to purchase the alcohol, was given to officers and was horizontal. The ID had Collins's picture and name however the date of birth was 08/27/1999. Collins's date of birth is 4/27/2003 on his Florida issued driver's license. Collin spontaneously uttered to Officer Z. Barker (ID 459), in summary, the identification he used to purchase the alcohol was in fact fake. Officer C. Witherspoon (ID 520) read Collins his Miranda warnings from a department issued preprinted card, to which Collins stated he understood.</p> <p>Collins was taken to Palm Beach Gardens Medical Center due to being heavily intoxicated. At approximately 3:05 a.m. I, Officer Sam Warren, responded to Gardens Medical Center located at 3360 Burns Road, Palm Beach Gardens, Palm Beach County, FL, in reference to a disturbance. The caller told Northcom dispatch the male was being violent towards staff. The male was threatening harm towards the staff, and they had to physically hold him down. Due to the disturbing actions by Collins the medical staff had to halt</p>
