The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a blue BMW 2-door (AL TAG #6493AY1) northbound on Howard Av N, approaching a red Chevy Camaro that was stopped at a red light at Cleveland Av W. The defendant's BMW failed to stop in time and rear-ended the Chevy Camaro, causing very minor damage and no injuries. After agreeing to pull into a parking lot and exchange driver information, the defendant fled the scene northbound. I pulled in behind the vehicle and immediately conducted a traffic stop for failure to exchange information. Upon initial contact with the defendant, he was identified via a FL DL and exhibited several clues of impairment, to include: Watery/Bloodshot eyes, blank/dazed stare, droopy eyelids, slurred/mumbled speech, moved with slow/deliberate movements, fumbling fingers, appeared sleepy/lethargic, was confused with his paperwork, admitted to drinking "3 to 4 beers at MacDintin's within the last hour", and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While speaking to the defendant, the driver of the Camaro noticed that I was a police officer and fled the scene. During the search incident to his arrest, the defendant was found to have a small Ziploc baggie containing a white powder in his wallet, which later tested presumptive positive for cocaine. While at CBT, the defendant provided 2 valid breath samples, measuring .162/.159 BrAC.
