The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/10/20 at 14827 Florida Av. N. at approximately 2226 hours, the defendant is observed via video surveillance in a long sleeve black t-shirt and skinny jeans smashing the rear window of the victim's Toyota Scion (FL ISFH28) with an unknown object, causing \$631.27 worth of damage. The defendant does not own the vehicle and does not have permission to drive it. The victim and witness observed the defendant inside Pegasus Lounge the same evening, wearing a black Acaia long sleeve shirt with the words, "I'm going though shit" in yellow across the chest. The shirt had an image (possible a crescent moon) on the back of it in yellow and skinny jeans. The defendant implied his guilt and admitted to the offense through an exchange of text messages with the victim and witness. The defendant spontaneously uttered to Pasco County Deputy Marshall #6730 "yea I broke a windshield." The defendant also admitted to the affiant post Miranda to the offense. The defendant was identified via FL DL.
