 Officer Lewis observed the defendant driving a white Lexus with FL tag LHFH27 on the roadway. He was speeding, 51 miles per hour in a 35 mile per hour zone, speed captured by radar. He conducted a traffic stop and made contact with the defendant who was the driver of the vehicle. Upon contact he observed signs of impairment and requested a DUI officer to respond. I made contact with the defendant and could smell the odor of alcoholic beverages coming from his breath as he spoke to me. His eyes were glassy and bloodshot.
