


<p>The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law</p> <p>The Person taken into custody...</p> <p><input checked="" type="checkbox"/> committed the below acts in my presence. <input checked="" type="checkbox"/> was observed by MAJOR RODGERS who told OFFICER VALERIO that he/she saw the arrested person commit the below acts.</p> <p><input type="checkbox"/> confessed to admitting to the below facts. <input checked="" type="checkbox"/> was found to have committed the below acts, resulting from my (described) investigation.</p> <p>On the 20 day of March, 2021 at 17:25 (Specifically include facts constituting cause for arrest.)</p> <p>On Saturday, March 20, 2021 at 5:25 PM, I (Officer Valerio) was working an off duty detail at the Honda Classic located at the PGA Resort and Spa at 400 Avenue of the Champions within the City of Palm Beach Gardens, Palm Beach County, Florida. My body worn camera was activated during this call.</p> <p>I was dispatched to the 18th tee box on the golf course in reference to assisting Palm Beach Gardens Fire Rescue with a down subject. Upon arrival, I observed fire rescue assessing a white male, later identified as Jackson Shoenfelt through his FL Driver's License. Shoenfelt displayed obvious signs of being intoxicated (Glossy red bloodshot eyes, slurred with incomprehensible speech, and had a strong odor of an unknown alcoholic beverage emitting from his breath) while lying on the ground. Fire rescue advised due to the current medical status of Shoenfelt he would need to be transported to the emergency room for further evaluation. Fire rescue placed Shoenfelt onto their golf cart and escorted him back to the command post where there was an ambulance waiting for him.</p> <p>As we arrived at the command post, Shoenfelt stood up off the golf cart and began walking towards the ambulance with fire rescue. Shoenfelt looked backed and then took off running from both fire rescue and I. Shoenfelt ran in a northwest direction from the command post area and onto Avenue of the Champions. I notified communications of Shoenfelt's last known location and clothing description.</p> <p>Sergeant Geoffrey Soule and Officer Mark Zakian located Shoenfelt still running northbound on Avenue of the Champions. Both officers told Shoenfelt to stop several times, but he continued to disregard their commands and kept running away entering the Glenwood Community located to the east when they lost visual. Major Paul Rogers advised he entered the 1300 block of 13th Terrace where he observed Shoenfelt walking east and looking back toward the location of Sergeant Soule and Officer Zakian.</p>

<p>Major Rogers attempted to make contact with Shoenfelt and after giving him multiple commands, Shoenfelt eventually surrendered and was placed into handcuffs. Officer Myers McCray arrived on scene and assisted Major Rogers with taking Shoenfelt into custody. After Shoenfelt was placed into handcuffs, Officer McCray began to double lock the handcuffs. Shoenfelt bladed his body away from Officer McCray and appeared as if he was going to walk away. Officer McCray leaned him up against a patrol car where he attempted to double lock the handcuffs again. Shoenfelt began tensing his muscles and pressing his body against the patrol vehicle to prevent Officer McCray from double locking the handcuffs. Officer McCray and I gained control of Shoenfelt's arms and held him against the patrol vehicle until Officer McCray was able to double lock both handcuffs.</p> <p>When we arrived back to the command post, I completed a search of Shoenfelt's property. I located inside of his wallet a small, buttoned pouch. Inside of the pouch was a white powdery substance inside of a small zip loc bag. The white powdery was tested with a Sirchie Nark cocaine id swipe and tested positive for cocaine.</p> <p>Due to Shoenfelt being transported to the hospital, he was released with a notice to appear for resisting without violence. I am requesting a warrant be filed for the possession of cocaine.</p> <p>Based on the above investigation, I find probable cause exists to charge Shoenfelt with possession of cocaine and resisting without violence pursuant to F.S.S. 893.13(6) (A) and F.S.S. 843.02</p> <p>No further information.</p>
