The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On February 20, 2021 victim Ali Abdulabbas was stopped on Skipper Rd. at the light to turn left onto Bruce B. Downs Bl. in his white 2017 Ford Mustang bearing Florida license plate#: PJJ151 (VIN: 1FATP8UH6H5345559) when he was struck from behind by a silver 2004 Jeep Wrangler bearing Florida license plate#: HSGC04 (VIN: 1J4FA69S74P758035) operated by the defendant. The collision caused approximately \$400.00 in damages. When the victim got out of his car to check on the damage, the defendant fled the scene. The victim followed the defendant until Deputies could come into contact with both parties. The victim positively identified the defendant as the driver of the vehicle. Deputy J. Spear ABN#: 245769 made contact with the defendant and observed him to have bloodshot watery eyes, slurred speech, to be unsteady on his feet, and he detected the odor of an alcoholic beverage emanating from the defendant's breath. Deputy P. Campisi ABN#: 258804 made contact with defendant and observed him to have droopy eyelids, slurred speech, and he detected the odor of an alcoholic beverage emanating from the defendant's breath. I made contact with the defendant and observed him to have bloodshot watery eyes, low slow slurred speech, to be lethargic, to be unsteady on his feet, and I detected the strong odor of an alcoholic beverage emanating from his breath. The defendant performed standardized field sobriety exercises poorly indicating impairment. During an inventory search of the vehicle, I located an open Bud Light seltzer (5% alc.) in the center console cup holder. I located a Bud Light Seltzer box containing one empty can and 3 full cans behind the driver's seat. There was another partially empty can in the cup holder behind the center console and a full can on the passenger's side floor board. Once at Central Breath Testing, after a twenty-minute observation period, the defendant provided lawful breath samples showing a breath alcohol concentration of .167/.168. I confirmed the defendant's identity via DAVID.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
