On 3/19/20 at approximately 2:00 AM I was traveling north on SR-589 just south of W Waters Ave when i observed a White Ram Pickup truck enter SR-589 northbound. I observed the White Ram Pickup was unable to maintain a single lane, running off the roadway to the right multiple times. I activated my vehicles camera and further observed the vehicle's driving pattern.

The vehicle then exited SR-589 at the Waters Ave exit and began tot ravel east on Waters Ave. I activated my overhead emergency lights and initiated a traffic stop on the vehicle just west of Anderson Rd. The vehicle then turned into the 8-Eleven parking lot located just east of Anderson Rd. I made a drivers side approach and identified the driver by his Florida drivers license as Jacob Edward Mercer 3. Mercer's eyes were bloodshot and glossy, his speech was slurred, his movements were lethargic, and Mercer had a strong odor of an alcoholic beverage coming from his breath that got stronger as we spoke.

Upon backup's arrival i requested Mercer exit the vehicle to which he complied. I then explained to Mercer my concerns that he may be under the influence and requested Mercer to perform Standardized Field Sobriety Exercises to which he refused. I then explained to Mercer that if he refused to perform the exercises I would have to base my decision to proceed from here based on what I have already seen, I then explained the observations I have made to Mercer to which he still refused.

Mercer was placed under arrest for DUI and transported to the Orient Road Jail. While at the Jail Mercer refused to provide a breath sample. Mercer was read the implied consent warning to which he still refused.

Mercer was turned over to the Jail staff for booking purposes.
