limit. Trooper Zion Todd #4141 was in front of my patrol vehicle and conducted the initial traffic stop on the vehicle. The traffic stop was initiated at approximately 3:10 am southbound on State Road 9 (Interstate 95), just south of 10th Ave North on the left shoulder. Trooper Todd and I made contact with the driver who was identified as Jacob Gregory Slavinski by his Florida Driver's License #S415427944020. When I observed Mr. Slavinski, I observed glassy, watery eyes, a flushed face, and Mr. Slavinski talked with a slurred speech. Mr. Slavinski also had an odor of an unknown alcoholic beverage emitting from his breath as he talked. I had Mr. Slavinski step out of the vehicle and had him walk toward the front of my patrol vehicle. When Mr. Slavinski stepped out of the vehicle, I still smelled the odor of an unknown alcoholic beverage emitting from his breath. I had Mr. Slavinski walk toward the front of my patrol vehicle. When I asked Mr. Slavinski where he was coming from, he stated he was coming from "West Palm." Mr. Slavinski stated that he was going to his girlfriend's house in Delray Beach and was going to sleep there overnight. I then asked Mr. Slavinski where he was coming from and he stated, "Delray" and then he stated "Down South." I noticed that his slurred speech was becoming evident and he was not aware of where he was heading to.

I explained to Mr. Slavinski that based on the physical indicators in front of me and the totality of the circumstances, if he was willing to participate in the Standardized Field Sobriety Exercises. Mr. Slavinski said "No." I then advised Mr. Slavinski that if he refused the Standardized Field Sobriety Exercises, I will have to make an arrest decision based off the physical indicators in front of me and the totality of circumstances. I also advised Mr. Slavinski that anything up to this point in the DUI investigation can be used against him in the court of law. Mr. Slavinski again refused and stated, "No." Mr. Slavinski was arrested for DUI at approximately 3:18 am. Mr. Slavinski was then secured and transported to the Palm Beach County Jail.

Once I arrived at the BAT testing center, I conducted a 20 minute observation starting at approximately 3:48 am. Mr. Slavinski did not regurgitate or take anything by mouth. I requested Mr. Slavinski if he would provide a lawful sample of his breath and he refused. I read Mr. Slavinski implied consent and he stated he understood. Mr. Slavinski then refused again to provide a sample.
