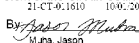


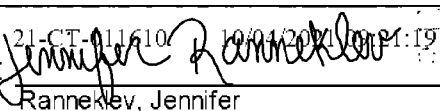

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a white Ford SUV bearing FL tag IBEH46. The vehicle was observed driving westbound on Kennedy Bv from Howard Av S. The vehicle continuously weaved in its lane, drifted to the left before swerving to stay in the lane. The vehicle continued in this driving pattern from Armenia Av to Himes Av. As we approached Himes Av in the outside lane, the vehicle again drifted to the left, causing an unknown vehicle in the inside lane to take evasive action. I suspected the driver to be sick, injured, or impaired and conducted a traffic stop on the vehicle. I initially activated my emergency lights as we crossed Himes Av. The vehicle had no response to my emergency lights and continued westbound before turning north onto Sterling Av. The vehicle continued driving northbound with no regard to the flashing red and blue lights behind him. I activated my siren as he approached North B St. The vehicle stopped at the stop sign and again continued driving without response to the siren or lights. The vehicle made an abrupt turn into the driveway at 311 Sterling Av and the defendant exited the drivers seat as I approached. The defendant had a dazed look on his face and appeared surprised by my presence. I noticed that his eyes appeared to be glassy, his face was flushed, and as he spoke his speech was slurred and thick tongued. I detected the odor of an alcoholic beverage emanating from his breath. The defendant was unsteady on his feet. The defendant admitted to drinking. The defendant attempted to walk away from me inside the residence when asked to participate in SFSE's. Based on the totality of the circumstances, I arrested the defendant for DUI. The defendant refused to provide a breath sample after being advised Implied Consent. The defendant was ID'ed via FL DL.
