The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 04 day of MAY, 2020, at approximately 5:29 PM, at 6220 65TH ST N, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE JESSICA HUBBARD, HIS GIRLFRIEND, AND CO-HABITANT, AGAINST THE WILL OF JESSICA HUBBARD, TO-WIT: PUSHING HER TO THE GROUND.

THE VICTIM AND SUBJECT HAVE BEEN IN A DATING RELATIONSHIP FOR THREE YEARS, LIVE IN THE SAME HOUSEHOLD, AND HAVE A CHILD IN COMMON. THE SUBJECT AND THE VICTIM GOT INTO A VERBAL ARGUMENT WHEN THE VICTIM RETURNED HOME FROM THE STORE. THE VICTIM CLAIMED THAT THE SUBJECT HAD TAKEN HER PHONE AND WAS ATTEMPTING TO LOOK THROUGH IT. THE VICTIM CLAIMED THAT THERE WERE LARGE AMOUNTS OF SENSITIVE INFORMATION AND DOCUMENTATION OF THE ONGOING DOMESTIC ISSUES BETWEEN BOTH PARTIES. THE VICTIM CLAIMED THAT SHE ATTEMPTED TO GRAB THE TELEPHONE AND THE SUBJECT PUSHED HER TO THE GROUND. POST MIRANDA, THE SUBJECT ADMITTED TO PUSHING HER TO THE GROUND. THE SUBJECT ALSO STATED THAT AFTER THE INITIAL PUSH THE VICTIM ATTEMPTED TO LEG SWEEP HIM AND HE AGAIN PUSHED HER TO DEFEND HIMSELF. I DETERMINED THAT THE SUBJECT WAS THE PRIMARY AGGRESSOR DUE TO THE INITIAL PUSH TO THE GROUND.

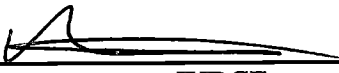
ADVISORY AND SOLVENCY HEARING

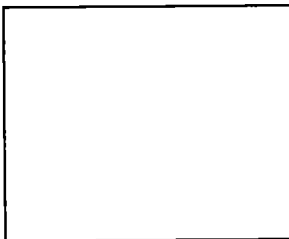
