The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On May 15, 2020 at approximately 1756 hours, the affiant was operating her unmarked Dodge Charger patrol vehicle headed northbound on Falkenburg Road South in Tampa, Florida within Hillsborough County. As the affiant proceeded northbound crossing over Adamo Drive East, a black Hyundai Sonata conducted a left U-turn on a steady red traffic signal and impeded the affiant's right of way. In addition, the black Hyundai Sonata bearing Florida tag:NCCU46(V.I.N.:5NPE24AF6HH490954) opaque black tinted windows and a tag inquiry yielded the female registered owner's Florida Driver License was suspended and there was a seize order issued by the DHSMV on the vehicle. The affiant conducted a traffic stop of the Hyundai Sonata and on contact with the driver/defendant she identified herself as the registered owner via Florida Class E Driver License. As the affiant was speaking with the defendant, she detected indicators of impairment to include; bloodshot glassy eyes, the odor of an alcoholic beverage emanating from her breath, fumbling fingers as she was searching for paperwork, there was lipstick smeared all over her mouth area, there were food and make-up stains all over her clothes, and she was disoriented (she kept handing the affiant the same incorrect paperwork not comprehending affiant's requests). The affiant requested the defendant exit the Hyundai Sonata. As the affiant continued to speak with the defendant, she detected further indicators of impairment to include inability to stand still or follow directions. The affiant requested the defendant perform field sobriety exercises which she agreed to do. Throughout the performance of the exercises, the defendant displayed indicators of impairment and was subsequently arrested for Driving Under the Influence and Driving While License Suspended with Knowledge of Financial. The affiant transported the defendant to Central Breath Testing where after a proper twenty-minute observation period was conducted, she provided two lawful breath samples of .124/.120% B.A.C. respectively. The defendant's Florida Driver License was suspended on 3/25/2020 with notice provided on 3/10/2020 Case #: 732207764.
