The defendant was stopped for driving at night without lights while traveling north on Howard Ave N, approaching Carmen St W. The defendant was driving her 2021 Mazda CX-5, bearing FL tag #5424QF. Upon making contact with the defendant, she displayed multiple signs of impairment, including: bloodshot/glassy eyes, a distinct odor of an alcoholic beverage on her breath, fumbling with her documents, and an admission to consuming alcoholic beverages. The defendant exhibited clues of impairment during the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .154/.164.

The defendant identified herself via her FL driver's license.
