The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 7/19/2020, at approximately 1725 hours, Deputy M. Quintana ABN 258202 was dispatched to a reckless driver call for service. The comments in the CAD call stated "....FEM DRIVER//CP ADVD DRIVER IS IMPAIRED REF STUMBLING AROUND GOING IN AND OUTSIDE VEH." HCSO Dispatch advised Deputy Quintana the vehicle is a silver Chevrolet bearing FL tag BCCZ14. Deputy Quintana located the vehicle at the response location with the defendant in the driver seat of the running vehicle, and detected signs of impairment. Affiant responded to the scene, observed the defendant's eyes to be bloodshot and glassy, her speech was slurred, she was unsteady on her feet, and her eye lids were droopy. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment, was unable to stand erect without assistance, therefore Affiant terminated the remainder of the SFSEs for the defendant's safety, and subsequently arrested her for DUI. The defendant agreed to provide a lawful urine sample to determine the presence of chemical and/or controlled substances. Deputy D. Wells ABN 254768 collected the sample, Affiant took possession of it and impounded it into the Evidence Control Section. The defendant was identified via FL DL. The defendant was given a Uniform Traffic Citation ADT92NE which reflects the DUI charge.
