infant Ivy D Huxtable (08/29/2020). I later made contact with white male Jacob D Huxtable (03/07/1989) who was on the balcony. Jacob advised that approximately 30 minutes prior to the him calling his wife, Jade had broken in to their shared bedroom and demanded him to give her Ivy so that she could leave. Jacob advised he did not want Jade to take their baby and denied access to Ivy.

Jacob advised that Jade then grabbed his scrotum and testicles and squeezed them. Jacob advised he pushed Jade against the wall. Jacob then attempted to take Ivy out to the balcony when Jade grabbed him by the arm and squeezed/ pinched him. Jacob let Jade have Ivy and left to the balcony. I then re-established contact with Jade.

Jade stated she got into a argument with Jacob because he abuses prescription Adderal and when he is not on the medication he never helps her with things around the house. Jade advised that Jacob took Ivy into their shared bedroom after the argument started and locked the door. Jade advised she used a steak knife to pry open the door. Jade stated that she then tried to take Ivy away from Jacob with negative results.

Jade advised she grabbed Jacob's scrotum and testicles and squeezed them. Jade stated that Jacob shoved her against the wall. Jacob then tried to take Ivy away and she pinched his arm in order for Jacob to let Ivy go. Jade obtained Ivy and Jacob left to the balcony.

I observed Jacob with a visible injury in the form of a bruise on his left bicep where he said he was pinched. He also said his testicles were injured and requested EMS to respond. Palm Beach County Fire Rescue responded and met with Jacob. Jacob denied transport and was evaluated and cleared. Jade denied transport or evaluation on scene. Reference FD run#: 21-034728.

I determined probable cause to arrest Jade for domestic battery related to her being the primary aggressor during the violence. Jacob denied being photographed on scene and denied the request to fill out Lantana Police paperwork on scene.

I placed Jade into handcuff's and transported her to the Lantana Police Department for processing. I later transported her to the Palm Beach County Jail and turned her over to deputy custody.
