The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/17/2020, at approximately 0011 hours, Deputy C. LaVigne (ABN:35920) contacted the driver on a traffic stop for exceeding the speed limit. Upon contact with the defendant, the affiant detected the strong odor of an alcoholic beverage emanating from the defendant's breath and observed her eyes to be red/blood shot and watery. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. After a proper 20 minute observation period was conducted, the defendant agreed to provide two lawful samples of her breath. Breath technician J. Dail (ABN:254236) provided the affiant with the results and they are as follows: first BrAC sample .143%, second BrAC .145%. The defendant was positively identified via her valid Florida driver's license.
