Mr. Freitas, who is an unlicensed contractor, unlawfully contracted his construction services in exchange for a total of \$5,600. The Florida Department of Business and Professional Regulation and the Hillsborough County Building Department verified the defendant's non-licensure status. Additionally, the Hillsborough County Building Department confirmed the scope of work														
contracted by the defendant is regulated, requiring specific licensure as a contractor and the issuance of a building permit.															
The defendant was positively identified via his Washington driver's license, FERNAJ187JK.
