The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/01/2020 I responded to the area of Dale Mabry Hw. N. and Northdale Bl. for the report of a white Infiniti Q50 bearing Florida license plate#: HUBR59 "all over the road" and "been off the road several times." The complainant to the call was following the vehicle and their hazard lights were activated. I located the complainant and the white Infiniti Q50 at Dale Mabry Hw. N. and Carrollwood Springs Bl. I traveled behind the white 2018 Infiniti Q50 bearing Florida license plate#: HUBR59 (VIN: JN1EV7AP7JM353988) and confirmed the license plate. I observed the vehicle drifting and swerving. I also observed the vehicle drive onto a raised concrete median, drive down the grass in the median, and strike a plastic upright. I conducted a traffic stop on the vehicle to see if the driver was ill, tired, or impaired. I made contact with the defendant (driver) and observed him to have bloodshot and glassy eyes and I detected the odor of an alcoholic beverage emanating from his breath. The defendant performed standardized field sobriety exercises poorly indicating impairment. Once at Central Breath Testing, after a twenty-minute observation period, the defendant provided lawful breath samples showing a breath alcohol concentration of .155/.147. I confirmed the defendant's identity via DAVID. Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge.
