The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 04/18/2020, at approximately 0326 hours, the defendant was operating a 2007 grey Honda Civic bearing NY tag JLL7684 (VIN:1HGFA16887L128992) on Shore Pw just northeast of Memorial Hw. The defendant took a roundabout at a high rate a speed and stuck the raised curb. As a result, the defendant lost control of the vehicle and struck a large boulder and then a unoccupied Chevy Avalanche bearing FL tag GKGM04 (VIN:3GNFK22039G193127). The witness was the passenger in Civic, and he positively identified the defendant as the driver of the Civic at the time of the traffic crash. It should be noted, the defendant had the keys to the Civic in his pocket and is son of the registered owner. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. Post Implied Consent, the defendant provided a lawful breath sample which resulted in a BAC of .143/.145. The defendant was identified via NY DL.

Total damage as a result of the crash is valued at approximately \$8,000.
