The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/08/2021, at the above date and time, the defendant and victim engaged in a verbal argument within the garage of the residence. The argument escalated when the victim grabbed the defendant by both biceps and pushed her up against the wall. The defendant and victim proceeded inside the residence, at which time the defendant grabbed the victim by her left arm. The victim slapped the defendant on his left cheek in an attempt to get free. The defendant proceeded to grab both the victim's biceps again and threw her on to the ground, causing the victim to strike the back of her head on the ground. The victim attempted to retrieve her phone and told the defendant she was contacting law enforcement. The defendant took possession of the victim's phone and told the victim she could not leave the residence. The victim attempted to flee the residence and the defendant grabbed the victim from behind and threw her, causing her lower back to strike to a metal railing. During this encounter the victim scratched the defendant on the left side of his neck to free herself from his grasp. The victim eventually was able to flee the residence and ran to the Hillsborough Sheriff's District III Office to report the offense. The defendant's actions were against the victim's will. Small lacerations were observed on the left side of the defendant's neck. The defendant and victim have been dating for approximately two and a half (2 1/2) years and living together at the above residence for approximately one (1) year.

The victim positively identified the defendant as the one who committed the offense. The defendant was positively identified by is DAVID photo.
