On 04/24/2022 at approximately 1500 hours I, Officer David Morgan of Florida Fish and Wildlife Conservation Commission (FWC), observed a personal watercraft (PWC) heading northbound in the IntraCoastal Waterway (ICW) south of Palmetto Park Bridge, in Palm Beach County. The vessel was on plane in posted idle speed zone. I conducted a vessel stop to address the violation.

I made contact with the operator on vessel, FL 9566 SL, and he provided a Connecticut ID, CT DL #229151696. The ID came back to a Tyler Joseph Champagne. He had alcohol on his breath and was given a portable breath test to see if he had above a .02 breathe alcohol level for an person under the age of 21. He blow .155 and .139, respectively, exceeding the .02 threshold.

On the Connecticut license given was of an individual over the age of 21, however, a Florida ID # C512438011450, of Jake Thomas Champagne born on 04/25/2001 was present in his wallet and he confirmed that was in fact his ID and valid age.

Jake Champagne was arrested at 1507 hours for giving false information to a law enforcement officer.

All above events were captured on agency issued body worn camera and uploaded to the appropriate server.
