The defendant was stopped as he was in actual physical control of his vehicle, which was pointed out by a victim as the suspect vehicle involved in an aggravated assault with a firearm case (reference TPD case #20-569680). The defendant was operating his Blue GMC Jimmy SUV, bearing FL tag #PXDV51. The vehicle was stopped in the parking lot of the listed location with the engine running and the gear in drive. Upon making contact with the defendant, he displayed multiple indicators of impairment, including: slurred speech, glassy eyes, a distinct odor of an alcoholic beverage on his breath, unsteady on his feet, dilated pupils, and post-Miranda admission to consuming alcoholic beverages and smoking marijuana. The defendant performed poorly on the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .124/.129.

The defendant identified himself via his FL driver's license.
