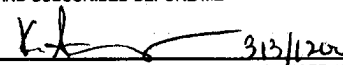


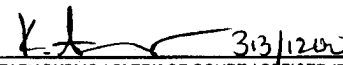

	On 04/11/2022 at approximately 2106 hours, I was conducting routine patrols on S.R. 811 (S Alternate A1A) in the area of Barrow Island Rd. in the Town of Jupiter, Palm Beach County, FL. At the time, I was driving southbound in my unmarked Jupiter Police Department patrol vehicle (vehicle 2109), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.							
	I was traveling southbound in the inside lane of S.R. 811 and I observed a silver Hyundai bearing FL tag # CYCK42 pass me in the outside southbound lane at a speed I believed to be exceeding the posted 50 MPH speed limit. The vehicle also had several registration stickers stuck to the center of the tag instead of the top right corner. I visually estimated the vehicle to be traveling approximately 70 MPH. I activated the front antenna of my STALKER DSR2X radar unit (S/N DB024105) in same-direction moving mode and received a digital speed readout of 71 MPH. My radar unit emitted a clear, constant audio Doppler tone consistent with a vehicle traveling the aforementioned speed and the patrol vehicle speed on my radar unit matched my patrol vehicle's certified speedometer.							
	At the time, there was one other vehicle traveling southbound (in the inside lane) on S.R. 811 but the Hyundai had passed it. I activated my overhead emergency lights and siren to conduct a traffic stop and the vehicle continued southbound in the outside lane with no acknowledgement from the driver that I was attempting to pull him over. The vehicle continued southbound for approximately 1 mile in the outside southbound lane and stopped for the red traffic light at the intersection with Admiral's Cove Blvd. I turned off my siren when the vehicle stopped at the light.							
	When the traffic light turned green, the driver proceeded southbound from the traffic light and continued without pulling over. I reactivated my siren and the vehicle

continued southbound, making no indication the driver was going to pull over. It should be noted that the entire southbound shoulder of S.R. 811 is grass and for the entire length I was behind the car, it could have pulled into the grass shoulder. Due to the fact that the vehicle was not stopping, I conducted a box-in maneuver with MPO Banegas and Officer Hobby to safely stop the vehicle just north of the intersection with W Frederick Small Rd. While conducting the box-in, the driver [later identified to be James Jones (w/m; 11/30/1971)] threw his hands in the air as if he was annoyed that the police were stopping him. It should be noted that the entire time my lights and siren were on, Jones' vehicle was the only vehicle in front of my patrol car and any reasonable person would have immediately known they were being stopped by the police. In all, Jones traveled a total distance of approximately one and one-half miles with my patrol vehicle behind it (approximately 1 minute and 15 seconds) with the lights and siren activated. When the vehicle stopped, we conducted a felony stop on the car. Jones had difficulty following simple instructions to keep his hands up while inside the vehicle and while officers were calling him back to the car. When Jones was in custody, I read him his Miranda Warnings. Jones advised he did not realize the police were attempting to pull him over. Jones stated he thought I was trying to pull someone else over (despite the fact that there were no other vehicles in front of me, or him). While speaking with Jones, I observed he had glassy eyes, a flushed face, slurred speech, and was clearly disoriented and unaware of his surroundings. Jones advised he drank "not much" when I asked but he would not clarify. Jones repeated questions over and over and could not understand what he did wrong. I transported Jones to the Jupiter Police Department and requested he perform Standardized Field Sobriety Tasks (SFSTs). Jones was argumentative with me the entire time and spoke over me incessantly. Jones advised he was being "treated like shit". I advised Jones that, if he continued his behavior, I would consider his behavior as a refusal to complete roadside tasks. Jones advised he did not understand why he was being pulled over and stated "that's all I'm gonna talk about." I asked Jones if he was refusing to complete SFSTs to prove to me that he was not under the influence. I also advised Jones that he did not have to complete roadsides when he asked if he was required to. I attempted to advise Jones of his Taylor Warnings and he continually asked what he was being charged with over my explanation. I attempted 4 times to explain the consequences of refusing to Jones and he never let me finish so I advised him DUI and refused obedience to law enforcement.

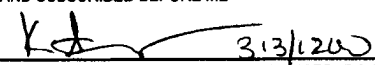

	I removed the handcuffs from Jones and was able to hold a brief conversation with him for a short amount of time. I asked Jones again whether or not he was willing to complete roadsides and was finally able to advise that if he refused to complete them, I would be forced to make a decision on whether or not to charge him with a DUI based on the evidence I had so far and his refusal could be used as evidence against him in court. Jones advised he understood and consented to perform SFSTs. I first conducted the Horizontal Gaze Nystagmus task. I am a certified Drug Recognition Expert (IACP # 32395) and I conducted this task in accordance with my training. Jones had pupils of equal approximate size, did not have resting nystagmus, and was able to track a horizontally-moving stimulus equally. I observed Lack of Smooth Pursuit and Distinct and Sustained Nystagmus at Maximum Deviation in both Jones' eyes. I did not observe the Onset of Nystagmus prior to 45 Degrees. Vertical Gaze Nystagmus was not present. Throughout the administration of the task, Jones was swaying in an orbital manner. I then attempted the Walk and Turn. I explained the starting position to Jones and he was unable to keep his feet heel-to-toe for more than a few seconds without losing his balance and stumbling off the line. While explaining the task to him, Jones advised "I don't think I could do this if I was..." and then caught himself. Occasionally while conducting SFSTs, a subject will advise the same statement and catch themselves before actually saying the word sober. I asked if Jones was going to say sober and he sat on the metal bench in the JPD holding room, giving the appearance he was finished with the tasks. Jones then advised he did not believe in the tasks. I asked if Jones wished to continue and he advised he did not. I secured Jones in a holding cell and immediately requested he provide a lawful sample of his breath for the purpose of determining the alcohol content. Jones agreed. While I was placing Jones in handcuffs to transport him to the Breath Alcohol Testing Facility, he demanded a drink of water. I advised Jones he could not have a drink until after the breath test. Jones then demanded to call his lawyer. I advised Jones his right to a lawyer did not apply to his decision to take a breath test. Jones then advised "I'm not doing anything else until I talk to a lawyer." I read Jones Implied Consent (excluding the CDL portion of Implied Consent) while Jones spoke over me the entire time. Jones advised he did not understand so I attempted to explain Implied Consent to him in layman's terms. Jones again spoke over me and stated "I think you're bombarding me with bullshit." Jones then continually demanded "I want a lawyer," over and over again and would not advise whether or not he would submit to a breath test. I called a refusal at 2139 hours. During my entire contact with Jones, he was argumentative, disrespectful, accused me of

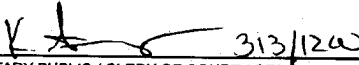

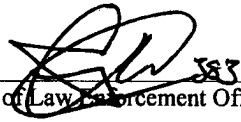

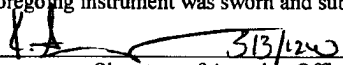
