The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 10/24/2019, at approximately 2227 hours, at Causeway Bl / Gornto Lake Rd S, Brandon, FL 33511, Deputy Buswell #3822 conducted a traffic crash investigation (see HCSO case #19-765106 and DHSMV crash report #89426522) involving a 2011 black Infinite M56, FL tag: DGSS56 / VIN: JN1AY1AP0BM520860) There was approximately \$4000 in property damag. The witness observed the defendant behind the wheel of the above listed vehicle. During his investigation, Deputy Buswell observed the defendant to have slurred speech, unsteady on his feet, slow response, and the odor of an alcoholic beverage on his breath Deputy Buswell also had to repeat every question to the defendant twice. Based on the observed indicators of impairment, Deputy Buswell requested a DUI investigator respond to the scene. Upon my arrival, I observed the same indicators of impairment listed above. The defendant was given the opportunity to perform field sobriety exercises, which he refused to perform. I explained to the defendant that if he were to refuse, I would be forced to base my arrest decision on the indicators of impairment observed. The defendant again refused. Subsequent to arrest, the defendant refused to submit to testing (after being read implied consent). The defendant was identified via their Florida driver's license.
